RULES AND REGULATIONS

Registrants are required to use the application and Brochure form and abide by **INDIAMART ELASIA - 2009**, Rules and Regulations as specified below :

The prospective Exhibitor should apply on Application Form for Participation together with payment. Allotment will be on 'first-come-first served' basis, subject to receipt of all payments. DD/Cheque should only be drawn in favour of "**M/s TRIUNE EXHIBITORS PVT. LTD.**", .

ORGANISER : Reserves the right to reallocate space, change the layout, add or delete corridors in space plans - which may affect the orientation of some **EXHIBITORS**. The decision shall be final. The organiser also reserves the right to turn down application for participation or even deny participation to Exhibitors already confirmed. All the payments are to be made latest by 30th Sep 2008. The booking of the stall / open space is liable to be cancelled if full payment is not received by the above date. In case the booking is cancelled by the Exhibitor, booking amount paid shall stand forfeited. The Exhibitors shall not organise concurrent show outside of **INDIAMART ELASIA-2009** in Chennai during the **INDIAMART ELASIA - 2009**.

The organisers will do their level best to ensure supply by the authorized contractors, but shall in no circumstance the Organiser will be responsible if such services cease to exist due to loss or damage.

EXHIBITOR : The Company enters into a contract, with the Organiser upon submission of this document. The Company (Proposed Exhibitor) agrees to participate at the Exhibition **INDIAMART ELASIA-2009** and abide by the regulations and by-laws, handed out to the company, before the Exhibition. Upon any breach of contract by the company (Proposed Exhibitor) the company is liable to pay the space rentals in full, to the Organiser.

ELECTRICITY : Available at 230 V Single Phase and 400 V. Three phase A.C. 50 Cycles. Charges as additional requirement per HP on chargeable basis, these charges are subject to revision. The Organiser will provide Electricity at a Suitable point in the Stand. Internal distributions to the Machinery/Equipment will have to be arranged by the Exhibitors Electrical Contractor at their own cost.

SALE OF EXHIBITS : Sales are not allowed during the Exhibition. However negotiations for sale may be conducted. Removal of any Exhibit during the Exhibition period is also prohibited.

HANDLING OF EXHIBITS, CUSTOMS AND IMPORT : Services for handling, Clearing and forwarding would be available at the Exhibition Grounds at extra cost. The Organiser would appoint Clearing and Forwarding Agents for **INDIAMART ELASIA - 2009** who would assist in handling and completing Customer formalities. If required, Exhibitor would be required to contact them directly for such assistance. Movement of Exhibits in the Exhibition Ground by agencies other than the Official Clearing and Forwarding Agents is prohibited.

POSSESSION : Possession of the stall will be given to the Exhibitor one day prior to the opening of the Exhibition.

The Exhibitor is not allowed to encroach on aisles or open space outside his stall.

REMOVAL OF EXHIBITS : Exhibition participants will remove all the display materials only on 19th Jan 2009 after 4pm onwards and before 10 am on 20th Jan 2009. Organiser will not be responsible if Exhibitor fails to comply with, condition enumerated in the Exhibitor's Manual.

DAMAGES TO THE EXHIBITION VENUE : Exhibitor must not make any damage to the floor or structure. In case of damage the cost specified by the Organiser will have to be paid within two days from the date of closure of the Exhibition. The Organiser reserves the right to seize and/or retain the exhibitor's property in case of non-fulfillment of their contractual obligation. The Organiser shall not be responsible for any damage caused to exhibits, which are taken in seizure.

STAND MAINTENANCE : No painting or use of nails/screws on the laminated panels will be allowed. Drawing pins or adhesive tapes could however be used.

CANCELLATION : For cancellations or withdrawals from participation if any, the payments made towards Participation Expenses will be forfeited.

INSURANCE : Against all ascertainable risks from transportation to display and removal should be done by the Exhibitors at their own cost. Organiser will in no way be responsible. Participants will insure their Exhibits against loss, damage, theft, fire etc., They will also ensure third party insurance for the total duration.

SECURITY : The Organiser will be providing **GENERAL SECURITY** in the Exhibition Hall from 16th -19th Jan 2009 only. However, it may be noted that security at individual stalls can't be arranged. The Exhibition Hall will be closed every day from 16th - 19th Jan 2009 at 7.00 pm and opened every morning at 10.00 am in the presence of minimum 10 participants every day.

PHOTOGRAPHY : The Organiser reserves the right to photograph any exhibit for their use.

All decision will be subject to Bangalore Jurisdiction only.

FORCE MAJEURE : If the exhibition is abandoned, cancelled or suspended in whole or in part by reason of war, fire, nature calamity, national emergency, labor dispute, the non-availability of exhibition premises or any other cause not within the control of the Organiser, the Organiser may, at their entire discretion, repay the Participation Expenses paid by the Exhibitor or part thereof, but shall be under no obligation to repay any part of such. Participation Expenses and shall be under no liability in respect of any actions, claims or losses.

ALTERATIONS OF SPACE ALLOTTED : In special cases the Organisers reserves the right to modify stall dimensions, and/or allot a stall of plus or minus 1 sqm area. Allotment of stall locations will be made by the Space Allocation Committee. No change of location will be allowed. No special preference will be considered. Allocation Committee's decision will be final.

GENERAL RULE : In addition to the above, the Exhibitor will have to abide by general rules of India Trade Promotion Organisation (formerly TFAI) for safety and maintenance as well as for aesthetic appeal.

AGREEMENTS, PERMISSIONS : All verbal agreements, permissions, individual approvals or special authorization shall be deemed To be valid only if confirmed in writing by the Organisers.
